# Open Houses Announced to Gain Community Input on The Bay

Design and planning firm Sasaki solicits ideas to help imagine the future of the site

**SARASOTA, FL** (**February 1, 2018**) – The Board of Directors of *The Bay* and design and planning firm Sasaki seek public input for opportunities to improve the environmental and economic sustainability of the 53 acres along US 41 between Boulevard of the Arts and 10<sup>th</sup> Street, ensuring it will be an enlivened, cultural destination with open, public access to the Bayfront.

"The future of *The Bay* is truly for our entire community and all ages," said Bill Waddill, Managing Director of *The Bay*. "We want the entire community to give us their feedback from the interactive open house sessions to better imagine the possibilities."

Three open houses will take place next week that will include interactive stations introducing the Master Planning team and process, exploring the history of the Bayfront, providing a summary of existing site conditions, and imagining the future. The community is invited to participate in any one of the three open houses to address what activities, destinations, and open spaces they would like to experience on the site.
